Limited Warranty



ViWinTech® warrants its ColorTech™ exterior coating to the original owner to be free from manufacturing defects for (15) fifteen years, following purchase.

Since the ViWinTech **ColorTech**™ system is a specialized coating, the coating is guaranteed under normal conditions, for a period of fifteen (15) years, against weathering, specifically, but not limited to, "peeling or blistering from or on the applied surface and significant ultraviolet discoloration" (greater than 6 Delta E units) caused by natural environmental atmospheric conditions. Should the **ColorTech**™ system fail due to product defect, ViWinTech at its option will either repair, replace or provide paint for the defective window or door. Any labor under this warranty will fall under ViWinTech's warranty terms

This warranty is not applicable under the following conditions:

1. If damage is caused by external factors (i.e. Stucco leach, acidic washes, hard tack tape, blowing sand, etc.)
2. If damage occurred during ViWinTech's customer's delivery or transport of painted PVC.
3. Any act of nature.

The Warranty expressed herein constitutes the buyers sole remedy whether arising in contract, tort, products liability or otherwise and, is in lieu of all other warranties expressed or implied, including the implied warranties of merchantability or fitness for a particular purpose.

How To Make A Claim

The owner / consumer must promptly notify the contractor or builder who installed the window(s) or door(s) in order to examine the product claimed to be defective. Proof of date of purchase and installation must accompany the claim. ViWinTech will be notified by copy of the contractor / builders report to the distributor. If said product is found defective, ViWinTech will within a reasonable amount of time address the defective product in question, per the warranty terms.
